744 is safe for use with all standard cleaning equipment.

Product Make-Up

744 is a concentrated industrial cleaner and degreaser. Dilute to specified strength concentrations.

Concentration and Application Methods

Grills

Scrape heavy debris from grill surface. Adjust temperature of grill to 150°F - 180°F. Spray or pour 744 on entire grill surface. Immediately clean grill with cloth or non-abrasive pad. Flush with water to remove any remaining soil. It is recommended a vinegar solution be used to neutralize grill after cleaning. Reprocess grill with plenty of cooking oils to prevent food from sticking.



Deep Fryers

Remove oil and debris. Fill deep fryer to grease line with water and add 1 to 4 oz. 744 per gallon of water. Boil. Cool, drain and flush. A vinegar solution rinse is recommended to neutralize deep fryer after cleaning.

General Cleaning

Use full strength or dilute to as little as 1 oz. per gallon of water depending on severity of grease and soil to be removed. Rinse well, preferably with a neutralizing vinegar solution.
